Alabama Case Management

Alabama Case Management is an automated system specifically designed to meet the needs of Alabama's municipal courts. The system has the capability of tracking traffic and non-traffic cases, as well as DUIs. Court dockets can be ordered and printed by defendant's name, arresting officer's name, case number, and case type. Another system feature includes the receipting of all revenue collected, the ability to handle partial payments and adjustments, and the distribution of court costs.

Alabama Case Management (ACM) contains and issues warrants, such as alias, capias, and arrest. Failure to Appear notices, Failure to Pay notices, suspensions; UTC25s, subpoenas, continuances, and bond forfeiture orders can also be easily executed and issued. ACM's comprehensive and extensive reporting abilities include, and are not limited to, payment histories, officer's statistics, receipts by date, outstanding cash bonds, outstanding warrants, outstanding fines and costs, and case action summaries. Daily drawer checkouts account for the money collected, while monthly reports, including the state report to the Crime Victims Compensation and the Peace Officers Annuity, are quickly and efficiently generated.

LGC's Alabama Case Management package offers several handy lookup features that make accessing information quick and easy. The system can be navigated completely with the use of either the mouse or keyboard. Laser and/or dot matrix printers are acceptable.
